Annette Dispence questioned if the Town had regular part-time employees with hourly rates.

Supervisor Chiavetta stated that most of the appointments are part-time, some departments are only budgeted for a certain number of hours and stick to the budget. Others tend to go over the budget amount year after year.

Leah Mirusso stated that if they continually go over, they could then come back to the Town for full-time benefits.

Annette Dispence stated that with the school, 26 hours per week and under is considered part-time.

Supervisor Chiavetta stated that the Town has never set the hours for part-time versus full-time and they may need to do so.

Carmen Vacco stated that if they don't consider this, someone may come back and try to sue the town for benefits.

Bill Henry questioned who is the Freedom of Information Act Officer. He was told that the Town Clerk was.

Councilman Rosiek stated that he was not aware of this appointment, if you need information you come in and ask for it. The Town Clerk stated that she does have the forms however, if she did not have access to the information, she would forward it to the appropriate department. She did state that there are certain items that are confidential such as income and personal items. Forms completed in the assessor's office based on income limits are not subject to the freedom of information act.

Attorney Grennell stated that some items are exempt from the Act but he was not certain of all the items. He would look more fully into the items and the possible appointment of a Freedom of Information Act Officer appointment.

Leah Mirusso questioned the shoveling of the sidewalks at the Town Hall, sometimes the snow is high making it difficult to enter. The Town Clerk stated that the Contract with DM&K did allow some shoveling and that they do try to come before 9:00 a.m. and court dates, however if we get any amount of snow, it can quickly accumulate. A suggestion was made to have the Superintendents of Buildings and Grounds check it when we get additional snow throughout the day.

A motion was made by Councilman Rosiek seconded by Councilwoman Bowman to appoint Rose Falk as secretary to the police chief as needed. MOTION CARRIED.
